PROPOSITION 2

Shall the Board of Education of the East Newton County R-VI School District, Missouri, be authorized to increase the operating tax levy ceiling to \$3.25 per one hundred dollars of assessed valuation to be phased in by \$0.25 to \$3.00 in Tax Year 2013 and by \$0.25 to \$3.25 in Tax Year 2014 in order to provide funds to retain qualified staff, maintain its facilities and meet operating expenses?

(If this proposition is approved, the adjusted operating levy of the School District is estimated to increase from \$2.75, currently, to \$3.00 per one hundred dollars of assessed valuation for the 2013 Tax Year; to \$3.25 per one hundred dollars of assessed valuation for the 2014 Tax Year and will be applied to the assessed valuation for each year thereafter.)

PROPOSITION KIDS

Shall the Board of Education of the McDonald County R-1 School District, Missouri, without an estimated increase in current debt service property tax levy, borrow money in the amount of Five Million Five Hundred Thousand Dollars (\$5,500,000) for the purpose of providing matching funds for the site development, construction, equipping and furnishing of the FEMA Safety Buildings (tornado shelter) to combine with resources from the Federal Emergency Management Agency (FEMA) at the Pineville School, Southwest City School and other locations authorized by FEMA; to construct, equip and furnish a Vocational Agricultural workshop addition to be located at the high school campus; to construct, equip and furnish additional classrooms and a new gym at the Pineville Elementary and Southwest City Elementary Schools to accommodate the tornado shelters as part of those projects; to complete other remodeling and repair improvements to the existing facilities of the District; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.67 per one hundred dollars of assessed valuation of real and personal property.
