PROPOSITION SAFETY**

Shall the Board of Education of the Southwest R-V School District of Barry County, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Five Hundred Thousand Dollars (\$1,500,000) for the purpose of completing safety and security improvements by constructing, equipping and furnishing a connected administrative office building between the Elementary and Middle Schools for a secure main entrance and constructing, equipping and furnishing a music room addition at the High School; to the extent funds are available, complete other repair and renovation improvements to the existing facilities of the District; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.85 per one hundred dollars of assessed valuation of real and personal property.
