RSMo Section 115.345. Notice of offices for which candidates are to be nominated, when sent—election authority to publish notice with filing date.— 1. Not later than the third Monday in December immediately preceding the primary election, the secretary of state shall prepare and transmit to each election authority a notice, in writing, designating the offices for which candidates are to be nominated at the primary election. 2. Upon receipt of notice, the election authority shall publish the notice and the date by which candidates must file for such offices in a newspaper of general circulation in its jurisdiction.

Declarations of candidacy may be filed for the following political officers who are to be **elected** at the Primary Election:

Township or Ward Committeeman
Township or Ward Committeewoman

* According to Statute 54.040 and 52.010: The candidate shall present to the election authority a copy of signed affidavit from a surety company authorized to do business in this state, indicating that the candidate meets the statutory **bond requirements** for the office for which the candidate is filing.

In addition, such offices as become vacant by expiration of term, by death or resignation of incumbent or vacant for any cause, and which under the law, should be filled at the general election to be held November 4, 2014.

FURTHER NOTICE IS GIVEN that at least one-half of the sites provided for voter registration shall be accessible to handicapped persons (RSMo 115.140). In addition, a disabled or elderly citizen may register to vote by alternative means including registration by mail, and curbside registration.
